GENERAL CONDITIONS

- 1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Gorakhpur, Uttar Pradesh.
- 2. <u>Application Process:</u> -The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through <u>Offline</u> mode. The applications in respect of above said posts along-with other relevant information will be available on official website of AIIMS Gorakhpur i.e. http://www.aiimsgorakhpur.edu.in
- 3. The last date of receiving of completed application form at AIIMS Gorakhpur: 19th December 2022, 05:00 PM
- 4. The applicants applying advertisement should check their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of applications failing which their application will be rejected.
- 5. In case a candidate wishes to apply for more than one post, he/she is required to fill the form separately for each post.
- 6. The candidates have to send signed copy of offline application form along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc. In support of their candidature. The Experience Certificate should clearly how the period of experience, duration of experience ("from"to"to"), nature of experience (either teaching or research) etc. Candidates can only mention those teaching experiences which are recognized by MCI/Govt. of India.

- 9. Maximum Age Limit: -

Professor/Additional Professor: -Not exceeding 58 (Fifty-Eight) years as on the last date of the receipt of the application.

Associate Professor/ Assistant Professor: - Not exceeding 50 (Fifty) years as on the last date of the receipt of the application.

- (i) Upper age limit shall be determined as on last date of submission of offline applications.
- (ii) No age relaxation would be available to SC/ST/OBC/EWS candidates applying for unreserved vacancies.
- (iii) Age relaxation permissible to various categories is as under: -

Maximum age limit for applying for the aforesaid posts on deputation is 56 years as on last date of receipt of application. Retired Faculty from Institutes of National Importance (INIs) and Government Medical College (GMCs) at the level of Professor, Additional Professor and Associate Professor up to age of 70 years are eligible for applying on contract basis.

10. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered subjected to Caste/Disability/EWS Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.

- 11. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non-creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the government of India in this respect from time to time. Applicants should as certain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belongs to Creamy Layer and their subcaste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s). Similarly, EWS certificate will be strictly as per the instructions of the Government of India.
- 12. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format.
- 13. The candidates are to satisfy all eligibility criteria before Offline application. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
- 14. Qualifications and Experience: Qualifications and experience as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The experience will be counted as on last date of submission of Offline application (i.e. 19th December 2022). The equivalent qualification will be decided by the Competent Authority of AIIMS, Gorakhpur and his/her decision in this regard will be the final.
- 15. Short Listing/Methods of the Selection: The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on details of the candidate, the Screening Committee may short-list candidates for interview. If required there may be screening test to shortlist candidates for interview in case large number of candidates apply for a post or posts. Candidates called for interview will have to produce all relevant original documents as proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by AIIMS, Gorakhpur at time of Interview. The methodology of selection will be decided by the Selection Committee as deemed fit besides any other matter related to the selection process.
- 16. **Place of Interview:** Interviews will be held at AIIMS Gorakhpur or any other place as decided by the Executive Director, AIIMS, Gorakhpur. No TA/DA will be paid for appearing in the interview.
- 17. APPLICATION FEES:
